The guidelines/policy to grant permission to the faculty member to attend any STTP/workshop/FDP etc. during the vacations has been approved by the Hon'ble Vice-chancellor (**ANNEXURE-VI: Pages 70-71**). The procedure to grant permission to attend STP/Workshop/FDP etc. is as under:

The faculty member will be allowed to attend any STTP/ Workshop / FDP etc. during the vacation & test week only. The Head of the Deptt. will examine the application and recommend the case by carefully considering the following in case of recommendations during the semester.

- 1. The HOD shall make sure that the STTP / Workshop / FDP etc. is organized by an academic or research institute / recognized association / recognized organization / recognized society / professional bodies of national or international level.
- 2. The STTP / Workshop / FDP etc. is related to subject domain / own discipline / research area of the faculty member.
- 3. HOD must ensure the training program is essentially required for upgrading the subject knowledge / technique that is part of teaching curriculum or specialised training to enhance functional knowledge of the upgraded equipment facility.
- 4. In addition it is proposed that, HOD shall ensure that after completing the above programme, the faculty member involves/contributes towards the

department and students in the area of STTP by taking subject courses or expert talks therein.

ITEM NO. 03.07: UNIVERSITY FELLOWSHIP TO EACH DEPARTMENT PER YEAR TO PROMOTE QUALITY RESEARCH.

As per the meeting of the HOD of the University department held on 15.01.2019 in the office of Vice Chancellor. It was decided that one University fellowship will be given/allocated to each department per year. A committee was constituted vide no. DAA/MRSPTU/2019/2404 dated 23.01.2019 to decide the general terms & conditions, modalities, contingency grant and stipend etc. for awarding university fellowship to every department. The detailed guideline prepared by the committee is annexed at (ANNEXURE-VII: Pages 72-79).

ITEM NO. 03.08: TO INFORM THE AMENDMENT IN THE CHOICE BASED CREDIT SYSTEM - 2016.

Consequent upon the approval of Hon'ble Vice Chancellor the modification in the Choice Based Credit System -2016 were made. The following clause was added as sub section (c) of Point no. 4 of existing Choice Based Credit System 2016 (ANNEXURE-VIII: Page 80).

'The Dean Academic Affairs of the University in case of University Departments and Principal/Director in case of constituent/affiliated institutions may condone attendance shortage upto 10% in the total for reasons to be recorded in writing (owing to serious illness, calamity). The students who participate in any game / sports / competitions / attend the camps officially or with prior approval of the institution shall be treated 'ON DUTY' and not as absent'. The same was notified vide DAA/MRSPTU/Notifications/2018/51 dated 27.12.2018 (ANNEXURE-IX: Page 81).

ITEM NO. 03.09: TO CONSIDER THE CHANGE IN THE NAME/STATUS OF THE VARIOUS DEPARTMENTS OF THE UNIVERSITY.

The HOD's of the respective departments were asked to prepare the proposal regarding the change in the name of the departments vide letter no. 3721 dated 05.12.2018. In response to same letter, proposal regarding change of the name of the following departments has been received vide letter no. Arch/D/18-976 dated 06.12.2018 and letter no. Chem/19/827 dated 17.01.2019 (ANNEXURE-X: Page 82-85).

ITEM NO. 03.10: TO APPROVE THE MODIFICATION IN MIGRATION REGULATIONS – 2016.

To streamline the process of migration (Inter/Intra University) certain modification/suggestion were incorporated in the Migration Regulations – 2016 dated 07.01.2019, which were approved by Hon'ble Vice Chancellor (ANNEXURE-XI: Page 86).

1. Intra University migration to Lateral Entry students in 5th semester of UG Programmes will be allowed to those students who are eligible to register for 5th semester of their UG Programmes, only if the distance between the parent Institute and the Institute where migration is sought are more than 40 kilometers by road.

- The candidates shall not be allowed to change his/her Discipline/Programme of study in the process of migration.
- 2. When the student applies for Inter University migration from MRSPTU, Bathinda to some other University, during his/her degree/course, he/she will be issued NOC after depositing of Rs. 10,000/-
- 3. As per university migration rules, in case of Inter University migration in which the student wants to migrate from some other University to MRSPTU, Bathinda during his/her degree;
 - (i) The student should have passed all the courses of the first year of his/her Programme of the University from where he/she wants to migrate.
 - (ii) The Institute and the University where the student is studying and the Institute to which migration is sought, have no objection to the migration.
 - (iii) The student requires to submit attested hard copies of results and syllabus of the courses studied by the student during 1st year.
 - (iv) The syllabus of the other University should be mapped 70% with the syllabus of MRSPTU, Bathinda before migration to be allowed to the student.
 - (v) After mapping of the syllabus of other University with syllabus of MRSPTU, if it is found that 70% of syllabus is not similar/equivalent to the syllabus of MRSPTU, the student will be allowed to migrate if he/she agrees to take bridge course/repeat the course of deficit subjects.

The Item is placed before the Standing Committee of Academic Council for approval please.

ITEM NO. 03.11: TO INFORM THE CONSTITUTION OF BOC OF THE DIFFERENT DEPARTMENTS OF MRSPTU BATHINDA.

Consequent upon the approval of Hon'ble Vice Chancellor the Board of Control of the various/different departments of University were constituted to deliberate and advise the departments to decide/resolve various routine Academic matters of the respective departments (Annexure-XII: Pages 87-100). The term for Board of Control shall be a period of two years i.e., till 31st Dec., 2020. The Quorum for the Board of Control is a minimum of half of the members of the Board of Control including the Chairperson. The main functions of BOC are as under:

- i. To recommend admission of students for all classes in accordance with the Rules/Regulations of the University.
- ii. To lay down the procedure for selection of candidates for the award of scholarship and fellowship.
- iii. To advise the Head, on all administrative matters of general interest and to see that the departmental duties and privileges are equitably allowed to all the members of the Department.
- iv. To act as student counselors and to help in maintaining discipline in the Department.
- v. To advise the Head on matters of allocation of funds provided by the University to the Department for Research Development and various extracurricular activities of the Department.
- vi. To recommend applications for study leave, within the frame work of the Regulations of the subject.
- vii. To recommend allotment of supervisors to post graduate students.
- viii. To consider the requirements of the Department for meeting emergent temporary appointments.
- ix. To prepare proposals for the new and additional demands for the annual and supplementary budget.
- x. To device ways for proper utilization of the non-teaching staff in the department.
- xi. Need-based proposals with justification for creation/upgrading of teaching posts in the field of the specialization and diversification of research activities shall be made by the department through the Board of Control. Such proposals shall then be examined by the Committee constituted by the Vice-Chancellor for screening the new and additional demands of the Departments.
- xii. A proposal for transfer of teaching post(s) lying vacant in a department to a new department or to other department/s would be examined by a Committee to be constituted by the Vice-Chancellor keeping in view the position of the department(s) concerned for filling up the post(s) in the department(s).
- xiii. A proposal for abolition of a teaching post(s), made by the department on the recommendation of Board of Control would be reviewed by the Committee to be constituted by the Vice-Chancellor.
- xiv. To prepare lists of equipment, chemicals accessories, furniture, stationery, etc., to be purchased, consistent with the requirements and available resources of the department.
- xv. To maintain up to date lists of firms to be addressed to for inviting quotations for purchase of various articles.

- xvi. To provide a periodic check on the maintenance of equipment and other items and to arrange for their repair or disposal, whenever needed.
- xvii. To advice on the proper maintenance and display of items in the Department, if any.
- xviii. To distribute teaching load and prepare time table; the latter in consultation with Dean (AA)/Director Campus.
- xix. To decide space allocation in the departments.
- xx. To propose starting of new courses/programmes in the departments.
- xxi. To propose procurement of new equipment/software.
- xxii. To recommend appointment of teaching staff as per need.

The Item is placed before the Standing Committee of Academic Council for information please.

ITEM NO. 03.12: TO INCLUDE COUNCIL FOR THE INDIAN SCHOOL CERTIFICATE EXAMINATION (CISCE/ICSE) FOR ADMISSION IN MRSPTU.

It was observed that certain news items have been published in media as well as with reference to MHRD letter in response to RTI application dated 07.01.2016 regarding the grant of recognition/validity/genuineness of the Council for Indian School Certificate Examination (CISCE). It has created much confusion about the status of this Council.

Thereafter a letter having no.DAA/MRSPTU/2018/2258/3517 dated 16.11.2018 was sent to Council of Boards of School Education in India, 6H BigJo's Tower, A-8 Netaji Subhash Place, Ring Road, Delhi to clarify the validity/genuineness of certificate issued by CISCE. Meanwhile, the students who have passed their qualifying examination from Council of Indian School Certificate Examination were provisionally allowed for the admission.

Thereafter, the reply received from Council for Indian School Certificate Examination is reproduced as under:

"It is mentioned that CISCE is a registered Society since 1967 under the Societies Registration Act. It was established with a view to administer the University of Cambridge, Local Examination, Syndicate's Examination in India. For more details, you may kindly visit http://www.cisce.org. It is pertinent to mention here that the name of CISCE/ICSE appears in Chapter-I of the Delhi School Education Act, 1973 (Act No. 18 of 1973) as an "examination conducting" body". (ANNEXURE-XIII: Pages 101-103).

ITEM NO. 03.22: TO APPROVE THE INTERNAL FACULTY FOR THE CONDUCT OF VIVA VOCE EXAMINATION.

As per the existing practice an external faculty is invited for the conduct of external viva voce examination at the end semester examination for B. Tech., M. Sc. / B. Sc. Programmes. It has been observed that sometimes the senior/experienced and qualified faculty as outside external examiners from other institutions is not easily available and also it involves lot of financial

obligations for the University. Whereas, in our University now we have experienced and qualified faculty, so it is proposed by the HOD Physics MRSPTU that for the conduct of external viva voce examination, some other faculty member of the same department may be allowed to act as external examiner in addition to the existing practice (ANNEXURE-XXVI: Page 1002).

ITEM NO. 03.23: TO APPROVE B. TECH. WITH MINOR ENGG. AND/OR B. TECH. WITH HONOURS.

In its model curriculum 2018, AICTE has made provision for B. Tech. with honours and B. Tech. with minor engineering. "A student will be eligible to get Under Graduate degree with Honours or additional Minor Engineering, if he/she completes an additional 20 credits. These could be acquired through MOOCs." (ANNEXURE-XXVII: Page 1003).

It is proposed that the same may be adopted for the students of MRSPTU, Bathinda. The concerned BOS shall make provision for the same.

ITEM NO. 03.24: TO APPROVE PROCEEDINGS OF THE BOS (AGRICULTURE SCIENCES).

The meeting of BOS (Hons.) Agriculture was held on 7 March, 2019. The BOS suggested that;

"B. Sc. (Agronomy) and B. Sc. (Agriculture Economics) does not have much relevance in present national scene and scenario. However, these courses are being taught as elective subjects in the regular curriculum of B. Sc. (Hons.) Agriculture. Committee has also discussed that these courses are not being taught in any of the reputed university of the country and are also not in line with the ICAR education frame work".
 In view of above, it is proposed that B. Sc. (Agronomy) and B.Sc. (Agriculture Economics) may not be offered from Academic Session 2019-20.

2. B. Sc. Agriculture is being run in MRSPTU affiliated colleges for 2016, 2017 and 2018 Batch. The BOS recommended that "the nomenclature of B.Sc. Agriculture degree should be renamed as B.Sc. (Hons.) Agriculture. This will help in making this degree as a Professional Course and at par with the other Universities/Institutions and enable the students to get wider acceptance for higher education at National and International level". The proceedings of the meeting are placed at (ANNEXURE-XXVIII: Pages 1004-1005).

In view of above, it is proposed that the nomenclature of B. Sc. Agriculture may be changed to B. Sc. (Hons.) Agriculture from 2019 Batch onwards. The matter regarding change of nomenclature from 2016, 2017 and 2018 Batch is placed for deliberation and directions please.
