## NOTIFICATION

Provisional Admission Process for the Session: 2024-25

On the recommendations of Core Committee (Admissions) of the University, it is hereby notified that the **Provisional Admission Process** of Maharaja Ranjit Singh Punjab Technical University, Bathinda (for its Main Campus and Constituent Colleges) subject to the fulfillment of eligibility and other requirements for the Academic Session: 2024-25 shall be started *w.e.f.* **22**th **January**, **2024** (via Online Provisional Admission Portal) **upto the start of Centralized Counseling** for the interested candidates as per the following conditions:

- 1. Candidates may be allowed for the Provisional Admission (Session: 2024- 25) on the basis of First Come First Serve especially in those Programmes/Courses where the admission is last two years remained very low. Chairman (Admissions)/Associate Dean (Academic Affairs)/HoDs of the concerned departments shall recommend the name(s) of Programmes/Courses to be considered for Provisional Admissions subject to above mentioned conditions depending upon the last 2-years trend/seats filled of various Programmes/Courses.
- 2. Candidates will deposit Applicable Counseling Fee (Non-Refundable), Total Semester Fee (including Tuition Fee, Development Fee, Student Fund, Security, Other Charges, Exam Fee, Document Fee, Registration Fee etc.) for the Academic Session: 2024-25 and allowed for provisional admission after submitting Undertaking.
- 3. Candidates may also be allowed to deposit partial fee of minimum amount Rs. 10,000/- and Applicable Counseling Fee for the Academic Session: 2024-25 and allowed for provisional admission after submitting Undertaking. The above paid fee shall be adjusted in Total Semester Fee to be paid by the candidate.
- 4. In case candidate wants to surrender his/her seat taken through provisional admission and/or fails to fulfillment eligibility criteria etc., the amount of Rs. 10,000/ and Applicable Counseling Fee will not be refunded. However, the remaining part of fee (if any) shall be refunded before the start of centralized counseling and after the start of centralized counseling refund rules shall be applicable as per UGC/AICTE/University norms.
- 5. SC Candidates who wish to avail and eligible for PMSS, may also be allowed to deposit Applicable Counseling Fee (Non-refundable) for the provisional admission (Academic Session: 2024-25) after submitting Undertaking.
- 6. The University has all rights to cancel the provisional admission of any candidate due to administrative reasons. In that case, the University will refund the whole fee paid by the candidate.
- 7. These admissions are purely provisional and the final confirmation subject to the fulfillment of eligibility requirements, merit of admission and all other requirements for the Admission Process.
- 8. Candidates may allowed to deposit fee as per already notified fees for the Academic Session: 2023-24 till fee notification for 2024-25 comes into force. Change in fee (if any) may kindly be adjusted/taken accordingly.
