

## **Need and Structure of Undergraduate & Post- Graduate Courses in Town Planning in MRSPTU, Bathinda leading to award of degree in Bachelor/ Masters in Planning**

With India treading on the path of rapid and massive urbanisation, urban centres are growing at a faster pace. Last census held in 2011, placed level of urbanization at 31.1% with number of urban residents at 378 million spread over 7935 urban settlements. Even with low level of urbanization, India is ranked second among the urban systems in the world after China. Estimates made globally have placed India's urban population at 591 million in 2031 and 750 million by 2051. Number of metro-cities are estimated to increase from 53 to 67 by 2031 and ten million plus cities would number 9 in 2051 as against 3 in 2011.

Urban centres not only will house more population but would also be the major economic driver of the country and generators of employment. Globally urban centres have been the determinant of national prosperity. However, this prosperity depends upon how well planned and developed cities are. Planned development has been found to be the major driver in making the cities more liveable, productive, effective and efficient. Accordingly promoting their state of art planning to ensure planned development has assumed importance

With rapid growth and expansion, development and management of cities is becoming highly complex and professional. Complexity of planning is also emerging due to fast changing technologies and economies at local and global levels. Cities are gaining momentum in terms of their areas and extent of operation. Integration of societies and economies of the world are extending the operational domain from city to the regions and beyond, making the planning process all the more complex and essential.

Urban India has not performed with the required level of proficiency because majority of cities are growing without having input of planned development. Considering the need and importance for promoting planned development, professionally trained town and country planners are needed to usher an era of planned development and management in this country by evolving new strategies and state of art options. Accordingly, planning courses are needed in this country to provide required level of manpower to meet the growing needs of planning and the planned development.

Planning professionals are needed keeping in view the government agenda of developing initially 100 smart cities in the country with an outlay of more than Rs. 1,25,000 crores and launching of Urban Mission for developing Rural Clusters at an investment of 7,000 crores to promote planned rural development. Besides Swachh Bharat Mission and Housing for All, entailing huge investment in urban India in years to come. The program is being launched in a phased manner with the intent of making all urban centres smart over a period of time. Planning and designing smart cities would require the services of trained town planners and accordingly, it becomes critical to start planning schools in the country to create required professional town planners.

73<sup>rd</sup> and 74<sup>th</sup> Constitutional Amendment Acts, 1992, provides for urban/land use planning to be given to urban local bodies, which would require professional planners to prepare schemes for planned development of the urban centres at the local level. In addition, preparing District Development Plans and Metropolitan Area Development Plans, would also require the active and absolute involvement of planners to prepare such documents. Master Plans for urban centres are required to be prepared for promoting planned development of urban centre, which can only be prepared by the physical planners. Considering the fact that large scale urban development is being envisioned by the involvement of private sector, there will be numerous employment opportunities available for planners in the private sector, in addition to the public sector.

### **Need for More Planning Institutions**

As detailed above, there will be increasing demand for Physical Planners, with the level of urbanisation going up and urban centres increasing in number and size. However, there is limited availability of planners in the country. As against more than 530 Architectural institutions and Engineering Institutions running into thousands in the country, Planning Schools are in the range of 22-25 in number (including Institute of Town Planners, India). The list of 21 Planning Schools is annexed. Out of 21 planning schools, only 5 are imparting education at the under-graduate level whereas rest of the schools are either providing post-graduate level studies. Considering the intake of 40, the number of qualified planners would continue to be short of actual demand and requirement. In this region, the under-graduate level courses are being provided by School of Planning and Architecture, New Delhi, Vijayawada, Bhopal,

Hyderabad and GRPG School of Planning, GND University, Amritsar. However, post-graduate studies are being imparted in Murthal and Lovely Professional University in addition to SPA and GNDU.

## **COURSE STRUCTURE**

The 'Bachelor/Master of Planning' are professional technical courses that judiciously trains students in various aspects of designing, engineering, managing and resolving challenges related to human settlements besides taking care of specialisation at the masters' level in environment, housing, transportation, urban, regional planning, infrastructure planning, real estate etc

Under-graduate programme in planning will have a duration of 4 years and would follow a pattern of Semester System. Accordingly, there will be 8 semesters of teaching, which will have duration and teaching hours on the pattern followed in other professional courses including Architecture and engineering. The 4 year duration will also include training component in the planning organizations to make students acquaint with the working of such organisations.

In case of Master Courses, the course shall be of 2 years duration divided into 4 semesters, which includes a thesis and 1-2 months summer training.

## **ELIGIBILITY CRITERIA**

Admission to the B Planning Course shall be after 10+2 qualification. There is no mandate of undergoing an aptitude test. However pattern varies from institution to Institution. SPA, Bhopal admits students on the basis of All India merit/rank obtained in the AIEEE. However in the case of GNDU, Amritsar, it is on the basis of score in the 10+2 exam. Further, there is also a variance in the subjects opted in 10+2. In GNDU, the pattern is same as followed in the admission to the B.Arch. Course. Accordingly, it is suggested that university can consider the option of following the admission criteria laid down for the Architecture Courses as detailed below:

a) Senior Secondary Examination (12<sup>th</sup> grade) with PCM and at least 50% marks in aggregate or any other examination recognized equivalent thereto.

b) Admission to be made on merit of the candidate in the qualifying examination

In case of masters' level courses, the eligibility shall be;

- B Arch, B Tech (Civil Engineering), MA( Geography, Economics, Sociology) or equivalent from a recognised university with minimum 50% in aggregate

## **INTAKE**

Annual intake shall be 30 students at B Planning/ 18 for Masters in Planning

## **APPROVALS**

In addition to other statutory approvals, course would also require the approval of Institute of Town Planners, India, located at 4\_A, Indraprastha Estate, Ring Road, New Delhi (Adjoining to SPA/IIPA )

## **FEE STRUCTURE**

Fee structure is to be decided by the university and the pattern followed in the admission to B. Arch/ M. Tech.Course can be considered for adoption.

## **COURSE CURRICULLA**

AICTE has prepared a model syllabus and course contents for the B.Planning course in 2008. The syllabus varies from institution to institution, which needs to be studied in detail by a group of experts before finalisation. The course contents evolved by AICTE can be followed. Course curricula for M.Planning can be evolved based on the existing structure and emerging needs of the profession.

## **EMPLOYMENT OPPORTUNITIES**

Students admitted to this four years intensive training programme are provided with broad knowledge and skills necessary to plan for integrated and balanced development of human settlements and areas of varying sizes. Upon graduation, the students have the options to seek employment in public/ private sectors or go in for higher studies. The major employers are Urban Local Bodies, Development Authorities, State Town and Country Planning Departments, Housing Boards, Regional Level Metropolitan Authorities, National Capital Region etc, In addition, all



developers/promoters are looking for the services of qualified planners to plan and develop townships/ colonies. Profession also provides options for consultancy through private practice. Large number of private consultants are now becoming available which also provide options for employment Besides looking for employment, students can also go for higher studies for specialization, providing better employment opportunities of career promotion in practice/academics. Accordingly, the avenues of opportunities include:

- Professional planners in town and country planning offices throughout the country.
- Professional options in terms of securing employment with both public and private sectors which offer a range of jobs.
- Organizations providing services in the fields of urban and regional planning, housing, transportation, urban design etc
- The Institute of Town Planners, India has also accorded professional recognition to the Bachelor of Planning programme.
- Holders of the Bachelor of Planning degree are eligible for admission to master's programmes in Indian and foreign universities. These include specializations such as housing, landscape architecture, transport planning, architectural conservation, environmental planning, urban design, etc.
