Consequent upon the approval by the competent authority vide ref. no. VC/1839 dated 14.08.2020, MRSPTU is pleased to announce the following admission procedure for admissions 2020-21 for following categories of courses in its Main Campus / Constituent Colleges/ PITs/ PSAEC, Patiala.

First Two rounds of On-Line Centralized Counseling shall be conducted by MRSPTU, Bathinda as per the notified counseling schedule available on website. Every candidate shall have to register and log-in by depositing online <b>non-refundable one-time counseling fee of Rs 2000/-</b>.</li><li>2. Candidates, who have pre-registered for admission 2020-21 on MRSPTU portal earlier by paying Rs 2000/- shall not submit counseling fee again. Such students shall have to produce the receipt of payment at the time of reporting.</li><li>3. In case, after declaration of last round of online counselling result by MRSPTU, seats are left vacant then direct online counseling rounds shall be conducted by individual colleges on the basis of inter-se-merit upto the last date of admission.</li><li>4. Direct Online Counseling shall be done through online MRSPTU portal. Every student shall log in to the college concerned by paying online <b>non-refundable one-time counseling fee of Rs 2000/-</b>, if not paid in earlier centralized counseling rounds.</li><li>5. First round of direct counseling shall be executed as per the notified seat matrix uploaded on University website taking into account seats reservations. However, if seats remain vacant, these can be made open during the spot online counseling /reporting.</li><li>6. <b>Direct Online Counseling schedule/s should be advertised by individual colleges on their web-site.</b></li><li>7. Merit list prepared in each round shall be openly displayed to students and kept in record for scrutiny, if desired by University.</li><li>8. Vacant seats status after each round should be maintained by the concerned colleges and kept in record for scrutiny, if desired by University.</li><li>9. HoD/Head of the Institute shall submit an undertaking in regards to following the University/Punjab Govt admission related norms as applicable for 2020-21.</li><li>10. <b>Admission shall be done for the seats as approved by University/Statutory body for 2020-21.</b></li><li>11. For details on eligibility/ sanctioned intake/ reservations etc. please see University Information Brochure: 2020-21.</li><li>12. <b>Eligibility norms as notified by Punjab Govt for 2020-21 shall supersede University eligibility norms, wherever applicable.</b></li><li>13. Refund rules shall be as per latest AICTE norms.</li><li>14. The last date of admission to be notified separately on Univ web-site. www.mrsptu.ac.in as per AICTE/ State Govt. directions.</li></ol>

**Note: If any round/s as per the notified centralized counseling schedule does not get executed, owing to some unforeseen reasons/late or non-declaration of results, Institutes shall execute the same at their level in online direct counseling as per the vacant seat matrix in University Information Brochure following due procedures.**
