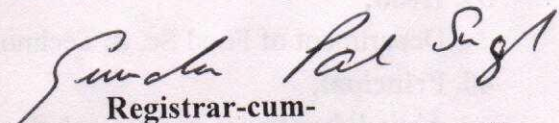

ITEM NO. 04.06. APPROVAL REGARDING MOU SIGNED WITH WAYNE STATE UNIVERSITY, DETROIT, MICHIGAN, USA ON 27-05-21

The University has signed MoU with Wayne State University, Detroit, Michigan, United States (WSU) on 27th May 2021, through which the eligible students can be accepted into the appropriate departments at WSU, after completing 3 years of their undergraduate Program at MRSPTU, under 3+1 or 3+2 Agreement (ANNEXURE-VI).

Under 3+1 agreement, the selected students of Bachelor Degree program in Engineering or Computer Science will study for the first 3 years at MRSPTU and they will be accepted by WSU in accordance with their policies. Each successful candidate will receive their Bachelor degree from MRSPTU and Bachelor Degree from WSU.

Under 3+2 agreement, the selected student in the assigned Bachelor's Degree Program to complete its first 3 years at MRSPTU and they will be accepted by WSU in accordance with their policies to study for 2 years at WSU. After the successful completion of 1st Year at WSU, the students will be awarded Bachelor Degree by WSU. Further, after successful completion of 2nd year at WSU, the students will be awarded with Master's Degree by WSU.
