UGC Guidelines on Examinations and Academic Calendar in view of COVID-19 Pandemic

Respected Madam/Sir,

In view of the Covid-19 pandemic and subsequent lockdown, the University Grants Commission constituted an Expert Committee to deliberate and make recommendations on the issues related to the Examinations and the Academic Calendar for avoiding academic loss and taking appropriate measures in the interest of students. The Expert Committee interacted with the stakeholders such as Vice-Chancellors of the universities, Principals of the colleges and academia through various electronic means such as email, phone, WhatsApp, online meetings etc. and submitted its Report to the UGC.

Based on the recommendations of the Expert Committee, the Commission has developed, "Guidelines on Examinations and Academic Calendar for the Universities in View of COVID-19 Pandemic and Subsequent Lockdown" A copy of the same is enclosed for your ready reference. The UGC Guidelines are advisory in nature, covering important dimensions related to examinations, academic calendar, admissions, online teaching-learning and provide flexibility for adoption by the universities. The universities may adopt / adapt and implement these Guidelines uniformly in a transparent manner.

In view of the location and diversity of universities and colleges, their level of preparedness, residential status of the students, status of COVID-19 pandemic spread in different regions / state and other factors, the universities, after making a comprehensive assessment of all such factors, may chart out a plan for the examinations and the academic calendar, to deal with any sort of exigency. It is reiterated that the universities should keep in view the best interests of all the stakeholders, giving highest priority to health and safety of all concerned, following the protocols for preventive measures, while adopting and implementing the Guidelines.

UGC Revised Guidelines on Examinations and Academic Calendar for the Universities in view of COVID-19 Pandemic

Respected Madam/Sir,

The University Grants Commission (UGC) has issued Guidelines on Examinations and Academic Calendar for the Universities in View of COVID-19 Pandemic and Subsequent Lockdown on 29th April, 2020. In these Guidelines it was proposed to conduct the examinations in July 2020. The said Expert Committee was requested to revisit the Guidelines for Examinations and Academic Calendar as the number of COVID cases are still rising and likely to increase further. The Report of the Expert Committee was considered and approved by the Commission in its emergent meeting held on 6th July 2020.

In continuation to earlier Guidelines issued on 29.04.2020 and based on the Report of the Expert Committee, the *UGC Revised Guidelines on Examinations and Academic Calendar for the Universities in view of COVID-19 Pandemic* were also approved by the Commission in its emergent meeting held on 6th July 2020. A copy of the same is enclosed.

In view of the emerging situation related to COVID-19 pandemic in India, it is important to safeguard the principles of health, safety, fair and equal opportunity for students. At the same time, it is very crucial to ensure academic credibility, career opportunities and future progress of students globally. Academic evaluation of students is very important milestone in any education system. The performance in examinations gives confidence and satisfaction to the students and is a reflection of competence, performance and credibility that is necessary for global acceptability. UGC is constantly making efforts to address various issues related to teaching, learning, examinations, academic calendar etc. in the difficult times of COVID-19 pandemic.

The Commission approved the recommendations of the Expert Committee regarding conduct of terminal semester(s)/ final year(s) examinations by the universities/ institutions to be completed by the **end of September, 2020** in offline (pen & paper)/ online/ blended (online + offline) mode.

The guidelines regarding intermediate semester/ year examination, as notified on 29.04.2020 will remain unchanged.

The relevant details, if need be, pertaining to the Admissions and Academic Calendar in the universities and colleges shall be issued separately in place of those mentioned in the earlier guidelines issued on 29th April, 2020.

You are requested to adopt the above guidelines and complete the terminal semester(s)/ final year examinations accordingly. It is reiterated that the Universities should give paramount importance to health and safety of students, faculty and staff and adhere to the Government protocols/ guidelines related to COVID-19 while conducting the examinations.

Subject: - Regarding grading of students of intermediate semesters in theory subjects for the semester Jan-Jun 2020 only in view of COVID-19 pandemic

With reference to UGC notices dated 06/07/2020 and 29/04/2020 and online meeting with Hon'ble Principal Secretary, Technical Education & Industrial Training, Punjab on 23/07/2020 and then on 10/08/2020 with Hon'ble Technical Education Minister regarding grading of students of intermediate semesters, it is proposed that MRSPTU, Bathinda can award grades to the students of intermediate semesters for the semester Jan-Jun 2020 on the basis of following:

1. 50% marks will be given on the basis of internal evaluation which may be based on mid semester examination, assignments, quiz etc.
2. Remaining 50% marks will be awarded on the basis of performance in previous semester only.
3. In the situation where previous semester / year marks are not available (as in the first year of annual pattern of examination), 100% marks / evaluation will be done on the basis of internal evaluation.
4. The students will be allowed to improve their grades by offering one additional opportunity to appear for the current semester / year in succeeding semesters / years.
5. As the university study scheme and software is for the 40% internal evaluation & 60% external evaluation, so in order to maintain this study scheme, the extra 10% of internal evaluation (out of 50%) will be adjusted in external evaluation. For example, if the student has 32 marks out of 40 which turns out to be 40 out of 50. So this 08 marks difference will be adjusted in external marks.

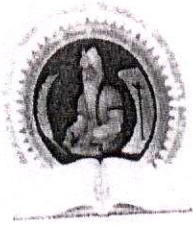

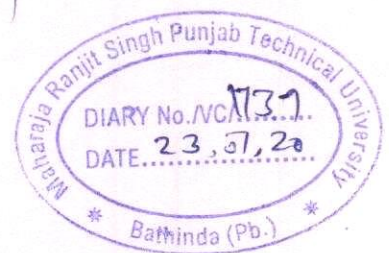

INTRODUCTION

-The term shall be extended on a year by year basis unless either party notifies the other in writing at least 6 months before the end of the ten-current term of its desire to terminate the Agreement.

-If either party breaches a material here in this Agreement may be terminated by the other party upon giving 6 months written notice of such breach.

-Students are required to meet English Language Proficiency (TOEFL, IELTS etc) requirements for direct entry into academic programs.

-Such acceptance is subject to there being seats available in the TRU Program when MRSPTU students apply.

-IELTS score should be 6.5 plus with no band below 6.0 in each module

-MRSPTU will also start new courses in future in collaboration with other colleges of different countries for higher study .

OBJECTIVES

- MRSPTU Bathinda has signed an MOU with Thomas Rivers University, Canada (TRU) with 2+2 scheme for which English proficiency is required. This provide inhouse assistance to the students in the light of this MOU IELTS coaching will be started.
- Youth wants to seek admission in higher studies abroad.
- B.Tech and BCA Students enrolled with University shall also be facilitated with this course.
- This course gives boost to student's potential to make their career in abroad.
- Indian students are used to a passive style of learning, will get to exposure to a more engaging and active learning style.

- B.Tech and BCA students enrolled with University.
- Students who are willing to move abroad for higher studies can also join and seek assistance regarding IELTS.

Agenda of Meeting: Discrepancy in Nomenclature of one of Engineering branches

Intimation regarding discrepancy in the name of one of the engineering branch was reported by Director PSAEC, Patiala vide letter no: PSAEC/822 Dated 15/12/2020 received on mail dated 16/12/2020. In this letter clarification in the name of Aerospace Engineering branch was sought. The esteemed members of BOS have gone through the contents of this letter and have checked the previous MOM of all BOS three meetings and related E Mails. The BOS members have decided as follows:-

- 1) The name of new branch Avionics Engineering was decided in second BOS held on 17/05/2019 from 2019-2020 sessions. Later on, it was observed that Avionics Engineering is not covered under AICTE nomenclature, so it was proposed in mail dated 27/05/2019 that it should be renamed as 'Aerospace Engineering' from 2019-2020 sessions itself.

- 2) However, the mail dated 29/05/2019 from AO, PSAEC has created little confusion as in this mail the name was suggested as Aerospace Engg (Avionics). However, no final decision on this name was taken in any of BOS by its members.
- 3) In the third BOS held on 05/05/2020, it was decided at item no 01.02 that "Aerospace Engineering" will have common syllabus with "Aeronautical Engineering" for first four semesters and syllabus for next four semesters (5th to 8th) will be prepared by BOS. However, regarding ongoing ambiguity in name of branch was not specifically clarified.
- 4) Today all the BOS members have unanimously agreed to keep the name of this branch as "Aerospace Engineering" for 2019-20 batch and all subsequent batches and as already decided in BOS dated 05/05/2020 at item no 01.02, the syllabus for first four semesters of this "Aerospace Engineering" is common with Aeronautical Engineering branch. The Syllabus of 5th to 8th semester of Aerospace Engineering shall be prepared in next meetings.
- 5) It is also clarified that as per BOS records, presently following two branches of engineering are running at PSAEC Patiala:-
 - a) B.Tech. (Aeronautical Engineering) – From 2018-19 admission batch onwards
 - b) B.Tech. (Aerospace Engineering) – From 2019-20 admission batch onwards

Intimation regarding this decision on name of branch as "Aerospace Engineering" from 2019-2020 batch and having common syllabus with Aeronautical Engineering for first four semesters shall be given by PSAEC, Patiala to office of Dean Academic Affairs and Controller Examination, MRSPTU, Bathinda.
This decision is final and supersedes all earlier BOS decisions and related earlier mails.



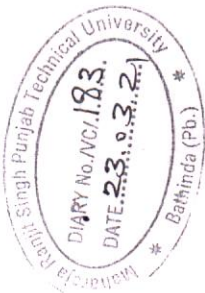


1. Pending University examinations of 2K20 Batch (UG and PG) 1st semester, 3rd semester, LEET and re-appear examinations should be postponed till further orders.


Ref: Detailed guidelines for reopening issued by DTE&IT, Pb vide TECH-TE-2010/256/2020-4TE2/I/102952/2020 dt 11.11.2020

In reference to above subject, keeping in view the comments received from various HoDs/Principals/ stakeholders, and above referred "**Detailed Guidelines for reopening of the Polytechnic/ Engineering colleges/Technical universities in the State of Punjab following the lockdown due to Covid-19 pandemic**", with the approval of Vice-Chancellor vide no. VC/2202 dated 17.11.2020, it has been decided that-

1. MRSPTU Main Campus/Constituent and its Affiliated colleges shall re-open for physical/offline/face-to-face/blended mode of teaching-learning for students in a phased manner w.e.f. 18.11.2020.
2. In the initial phase, PG/PhD scholars/students shall report in colleges. The colleges/Deptt, where no such students are on Rolls, shall call final year UG students w.e.f. 18.11.2020.
3. For all other batches, ongoing online mode of teaching/evaluation shall continue till further orders.
4. Consent of parents and students shall be sought before allowing the students in Campus/College/Deptt.
5. Heads of Colleges/Deptts/concerned authorities shall ensure that no overcrowding of students takes place in classrooms, library, other common places and while staying in hostels. Further, as per the above referred guidelines, Class timings adjustment/ weekends utilization/cutting of winter break and likewise measures may be adopted for fulfilling academic requirements as per UGC/Univ norms.
6. Students shall have to compulsorily wear mask, maintain social distancing, download and update Arogya Setu /Cova Punjab Applications in their mobiles, and do frequent hand- washing and follow SOP as issued by Govt. from time to time.
7. Colleges/Deptt shall have to ensure proper thermal screening of students, and regular daily sanitisation of classrooms/labs/common rooms/hostels etc.
8. Staff and students should be tested with RT-PCR for COVID-19 **before opening** following testing protocol. Colleges should make provision for the same in consultation with concerned authorities.
9. Colleges can reschedule their MSTs, if need be, under the ongoing admission scenario.
10. All other UG final/pre-final year students shall have to report w.e.f. 1.12.2020 for physically attending Practical Labs/ Projects/Drawing/workshops classes that can not be conducted effectively in virtual mode and seek close attention and supervision by teachers.
11. Reviewing of above measures shall be carried out in Mid-December 2020.

Directions/Duties for University Main Campus

12. Hostel wardens/Chief warden shall ensure compliance of Hostel norms as per Govt directions and intimate the students accordingly on University web-site under the supervision of DSW.
13. Estate Deptt shall ensure availability of thermal scanners/ sanitizers/ handwashing equipments/dustbins etc on regular basis at all common places under the supervision of Univ Estate officer.
14. DITeS shall ensure uninterrupted internet connectivity to sustain online teaching mechanism and upload needed information on University web-site for quick dissemination.
15. HoDs shall collect strength of reporting students for proper planning of time-table and grouping of classes/labs and conveying resource requirements to concerned sections/authorities. HoDs shall also be responsible in implementing SOPs amongst the reporting students in the Deptt.
16. Senior Medical officer, MRSPTU in consultation with Registrar shall make arrangements for Covid-19 testing and sharing updated SOP of Govt. with all concerned from time to time.
17. DSW will act as nodal officer for resolving all student related issues.





Sub: Re-opening Main Campus/Constituent and Affiliated Colleges of MRSPTU

Ref: Detailed guidelines for reopening issued by DTE&IT, Pb vide TECH-TE-2010/256/2020-4TE2/I/102952/2020 dt 11.11.2020

In reference to above subject, keeping in view the comments received from various HoDs/Principals/ stakeholders, and above referred "Detailed Guidelines for reopening of the Polytechnic/ Engineering colleges/Technical universities in the State of Punjab following the lockdown due to Covid-19 pademic", with the approval of Vice-Chancellor vide dt 17.11.2020, it has been decided that-

1. MRSPTU Main Campus/Constituent and it's Affiliated colleges shall re-open for physical/offline/face-to-face/blended mode of teaching-learning for students in a phased manner w.e.f. 18.11.2020.
2. In the initial phase, PG/PhD scholars/students shall report in colleges. The colleges/Deptt, where no such students are on Rolls, shall call final year UG students w.e.f. 18.11.2020.
3. For all other batches, ongoing online mode of teaching/evaluation shall continue till further orders.
4. Consent of parents and students shall be sought before allowing the students in Campus/College/Deptt.
5. Heads of Colleges/Deptts/concerned authorities shall ensure that no overcrowding of students takes place in classrooms, library, other common places and while staying in hostels. Further, as per the above referred guidelines, Class timings adjustment/ weekends utilization/cutting of winter break and likewise measures may be adopted for fulfilling academic requirements as per UGC/Univ norms.
6. Students shall have to compulsorily wear mask, maintain social distancing, download and update Arogya Setu /Cova Punjab Applications in their mobiles, and do frequent hand- washing and follow SOP as issued by Govt. from time to time.
7. Colleges/Deptt shall have to ensure proper thermal screening of students, and regular daily sanitisation of classrooms/labs/common rooms/hostels etc.
8. Staff and students should be tested with RT-PCR for COVID-19 **before opening** following testing protocol. Colleges should make provision for the same in consultation with concerned authorities.
9. Colleges can reschedule their MSTs, if need be, under the ongoing admission scenario.
10. All other UG final/pre-final year students shall have to report w.e.f. 1.12.2020 for physically attending Practical Labs/ Projects/Drawing/workshops classes that can not be conducted effectively in virtual mode and seek close attention and supervision by teachers.
11. Reviewing of above measures shall be carried out in Mid-December 2020.

12. Hostel wardens/Chief warden shall ensure compliance of Hostel norms as per Govt directions and intimate the students accordingly on University web-site under the supervision of DSW.
13. Estate Deptt shall ensure availability of thermal scanners/ sanitizers/ handwashing equipments/dustbins etc on regular basis at all common places under the supervision of Univ Estate officer.
14. DITeS shall ensure uninterrupted internet connectivity to sustain online teaching mechanism and upload needed information on University web-site for quick dissemination.
15. HoDs shall collect strength of reporting students for proper planning of time-table and grouping of classes/labs and conveying resource requirements to concerned sections/authorities. HoDs shall also be responsible in implementing SOPs amongst the reporting students in the Deptt.
16. Senior Medical officer, MRSPTU in consultation with Registrar shall make arrangements for Covid-19 testing and sharing updated SOP of Govt. with all concerned from time to time.
17. DSW will act as nodal officer for resolving all student related issues.





After due deliberations, it was decided that these OE courses shall preferably be offered from Engg & Tech streams.

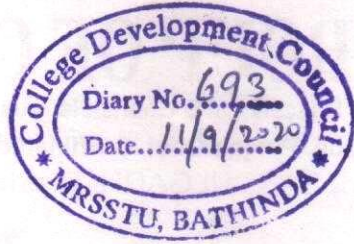

Sub: NCC as General Elective Credit Course.

Dear Sir / Madam,

NEP-2020 advocates Choice Based Credit System (CBCS) as integral part of education and it has been felt that NCC should be introduced as general elective credit course in technical institutions / universities to motivate students to join NCC in order to be disciplined and instil in them the feelings of patriotism. All students who enroll for NCC will immensely benefit by obtaining academic credits for NCC training in addition to acquiring NCC "B"/ "C" certificates, thus enhancing their employment opportunities.

Ministry of Education (then MHRD) in 2015 decided to implement the decision and UGC in 2016 also issued circular to all universities to implement the aforesaid decision taken. However, somehow it could not be implemented then.

In order to fulfil this objective, an in-depth study has been carried out by DG-NCC to have NCC as a General Elective Credit Course as per NEP-2020, under the "Choice Based Credit System".

Ministry of Education has now suggested to take appropriate steps in implementing the aforesaid decision.

You are, therefore, requested to extend this facility to your students, so that they may opt NCC as "General Elective Credit Course" from the academic year 2021-2022.

General

2. NEP 2020 was announced in the year 2020 by Gol and is on course for implementation in a phased manner.
3. The Ministry of Human Resource Development, as part of discussion in the JSR&D Conference held on 30th July, 2015 had decided to implement NCC as an elective subject. Accordingly universities were urged to implement NCC as an elective subject vide UGC letter No .D.O.No.F.I 4-25/2016(CPP-II) dated 11th November, 2016. However, it did not get implemented in the desired manner due to various factors.
4. Now with NEP 2020 having "Choice Based Credit System" (CBCS) as its component, it has been felt that NCC should be introduced as General Elective Credit Course in universities and colleges having NCC to make it more popular thereby benefiting the student fraternity enrolled with NCC.
5. In order to meet this requirement an 'in depth' study has been carried out by DGNCC to have NCC as a General Elective Credit Course as per NEP 2020, under the 'Choice Based Credit System'.

Proposal

6. It is proposed that UGC may issue instructions to all universities and autonomous colleges to implement NCC as General Elective Credit Course. The major benefits of the same are as follows :-
 - (a) All students who enroll as NCC cadets will immensely benefit by obtaining academic credit for NCC training in addition to acquiring valuable NCC 'B' and 'C' certificates.
 - (b) Strengthen NCC training standards by virtue of more accountability and expectation of students apart from extending due credit to Associate NCC Officers for their work load on NCC training.
 - (c) More students as cadets will be able to avail employment incentives and benefits offered under various Central and State Govt Schemes to NCC cadets. These benefits are appended at **Appendix 'C'**.

7. The Credit Course to be introduced in all universities and autonomous colleges across India which are currently having NCC Troops/companies as allotted by Headquarters DGNCC, including private colleges which have been allotted NCC under Fully Self Financed Scheme (FSFS). This will ensure that Credit Course do not exceed the current capacity of NCC to provide trainers and training infrastructure. This will also ensure smooth transition from present system to Credit Course System.

8. NCC has developed NCC General Elective Credit Course design that is uniform and universally implementable, which is in conformity with UGC policy on CBCS. The proposed model aligns with NEP 2020 thereby strengthening of NCC training.

9. Proposed course design for NCC General Elective Credit Course is appended as **Appendix 'A'**. The comprehensive NCC Course design document along with rules and regulations will be on the DGNCC website.

10. You are requested to issue suitable instructions to all universities and autonomous colleges for adoption of this proposal as given in Appendix 'B'. The concerned NCC Directorates of respective States/UTs will engage with universities and colleges to work out the modalities of implementation. Contact details of nodal person at Head Quarter DGNCC, New Delhi and respective NCC Directorates in the States/UTs are given as **Appendix 'B'**.

11. Likewise, Rashtriya Uchha Sikhsha Abiyan (RUSA) offices in States are urged to interact with respective State Govts and facilitate implementation of NCC as General Elective Credit Course in State Universities/ colleges with NCC units.

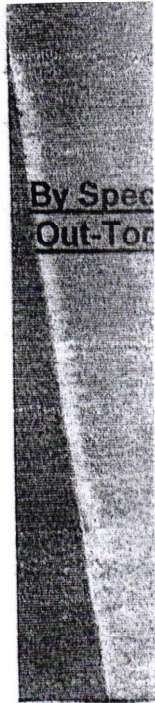

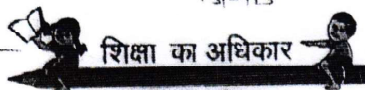

Please refer to DG NCC's letter number 4145/Elec Sub/DGNCC/Trg 'A' dated 7th October 2013 and subsequent reminder dated 27th July 2015 (Copies enclosed) regarding implementation of NCC as an elective subject by State Universities and Schools.

2. The matter was also considered in the JSR&D Conference held on 30th July 2015. Hon'ble Raksha Rajya Mantri, the Chairman, directed that implementation of NCC as an elective subject be taken up by all States in an early time frame and also desired that MoHRD may also process the case with all States.

3. NCC has already been taken up as an elective subject by 17 CBSE schools. 55 colleges nationwide have also implemented NCC as an elective subject. However, so far no State Government schools have taken up this scheme. The proposals have been forwarded by NCC State Dtes to State Education Departments for consideration.

4. In view of the above, you are requested to process the case for implementation of NCC as an elective subject with all States/Union Territories under intimation to DGNCC and Ministry of Defence.

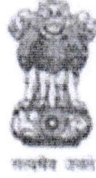
