

Item No. 18.1 To confirm the minutes of 17th Tender Finalization Committee.

The 17th meeting of Tender Finalization Committee of Maharaja Ranjit Singh Punjab Technical University, Bathinda was held online (google meet) on 24-12-2021. The minutes were circulated on dated 04-01-2022 vide ref. no. MRSPTU/Purchase/21-22/2060 dated 03-01-2022. No comments were received from any member of committee, so the minutes of 17th TFC is placed at (Annexure-I, Page No. 4-8) for confirmation.

Item No. 18.2 Regarding purchase of various items from the sanctioned capital grant of Rs. 1.00 Crore by Govt.

Capital grant of Rs. 1.00 Crore has been sanctioned by the Govt. Technical Education-2 Branch vide File No. TECH-TE-201/16/2021-4TE2 from Under Secretary File No. DTE-PLNGUSS(15)/1/2021-PLANNING by Deputy Director, Endst. on dated 14-3-2022 (Annexure-II, Page No. 9 to 12) for the execution of purchase within three months from the date of sanction alongwith the submission of utilization certificate. For the purchase of following items, the requirement was submitted to Principal Secretary, DTE&IT vide ref. letter no. 2165 dated 20-8-2021 (Annexure-III, Page No. 13 to 15). The capital grant is yet to be received in university account.

As the purchase for FY 2021-22 has to be executed within three months, so in anticipation of receiving grant in few days, the approval to initiate the purchase process has been taken from the vice chancellor on noting dated 28-02-2022 (**Annexure-IV Page No.-16**). The supply order for the same will be issued only after the receipt of grant in University Accounts. The purchase shall be done through GeM portal as far possible as per university regulation.

As per the decision of BOG, the purchase amounting more than 2 Lacs and above shall be made through e-tendering process.

The matter is placed before the tender finalization committee for deliberations and approval please.

Item: No. 18.3 Regarding purchase of Equipment & Furniture for setting up of Food Testing Laboratory sanctioned by MoFPI at Deptt. of Food Science & Technology of MRSPTU, Bathinda (Amounting Rs. 1,09,12,000/-).

The requirement for purchase of equipment & furniture has been received from Deptt. of Food Sci. & Technology for setting up of Food Testing Laboratory sanctioned by the Department by Ministry of Food Processing Industries (MoFPI), Govt. of India. The budget for the same is available from the second installment grant received from Govt. of Rs. 91,93,926/- with total balance amount of Rs. 99,98,961/- in project bank account. For the purchase of furniture, the university contribution @ 75% is also approved in budget of F.Y. 2021-22 (**Annexure-V, Page No. 17 to 24**). The administrative as well as financial approval has been accorded by Hon'ble Vice Chancellor. The approximate cost of the equipment & furniture is Rs. 1,09,12,000/-. The purchase shall be done through GeM portal as far possible as per university regulation.

As per decision of BOG, purchase amounting Rs. 2.00 Lac or above shall be made through e-tendering process.
