



Dr. Jatinder Kaur, Associate Professor, School of Architecture, New Delhi, was not able to attend the meeting due to some other engagement.

Dr. Bhupinder Pal Singh Dhot extended warm welcome to all the members followed by the commencement of the agenda of the meeting (Annexure 1) and explained the issues and decisions taken in 10th Board of Studies of GZSSAP, MRSPTU held on 20-04-2022 at 10:00 am to all the present members for information and ratification.

Agenda Item 1: Study scheme and syllabus of the new courses with L-T-P-C and duration of examination for

- *Bachelor of Design (Interior Design) (Annexure II)*
- *Bachelor of Fine Art (Applied Arts)(Annexure III)*
- *Skill Certificate Course in Graphic and Video Editing(Annexure IV)*

Decision: All members have approved these courses, its overall structure and study scheme for all Courses; Members strongly recommended the recruitment of faculty on Contract basis (for a minimum period of 3 years) for all the proposed courses.

Agenda Item 2: Regarding Exit policy for the new courses as per new education policy for Interior Design course. Students will get certificate after 1 year, B.Sci. Interior Design after 3 years and Bachelor of Design (Interior Design) after 4th years and in Bachelor of Fine Arts (BFA), certificate after 1 year, diploma after 3 years and Bachelor of Fine Arts (Applied Arts) after 4th years and the fee structure of new courses.

Decisions: Detailed deliberation held on this agenda in which present members have made some suggestions.

- Dr. Gaurav Raheja suggested to opt for Academic Bank of Credit (ABC), which will enable students to switch between institutions and multiple entries and exits to and from the programme.
- Ar. Sangeet Sharma was of view that there should be provision of rejoining the course after the gap/exit for the students. Ar. Ripu Daman Singh explained the university Academic Council rules for the same.
- Ar. Gaurav Raheja also pointed to reverify the nomenclature of three year B.Sci. Interior Design Course. The same has been checked from the various universities of the region and it has been found that the same nomenclature has been used i.e. B.Sci. Interior Design to award the Degree.
- On the basis of discussion following decisions has been made for the exit policy of proposed courses:
 - **Bachelor of Design (Interior Design):** Student will get Certificate in Interior Design after 1 year, B.Sci. (Interior Design) after 3 years and Bachelor of Design (Interior Design) after 4 years.
 - **Bachelor of Fine Arts (Applied Arts):** Student will get Certificate after 1 Year, Diploma after 2 years, and Advanced Diploma after 3 years and BFA (Applied Arts) after 4 years.
 - Also the fee structure has been devised out as;
 - i) B. Interior Design: as per the notification No. DAA/MRSPTU/Notifications/2019/56 dated 14/05/2019.
 - ii) BFA- Applied Arts: it was recommended to follow the same fee structure as of Bachelor of Interior Design.

Agenda Item 3: *To make necessary changes in the syllabus of the Bachelor's (Annexure V) and Master's (Annexure VI) programs being run under GZSSAP as per the NAAC guidelines and instructions from DAA, MRSPTU*


Decision: All members have approved the same.

Decision: As B. Architecture course is being governed by the Council of Architecture, New Delhi, therefore Members approved the implementation of new job recruitment and promotion







MRSPTU Admissions for the academic session 2021-22 were carried out as per the procedure notified vide no. DAA/MRSPTU/Notifications/112 dated 03.08.2021 and DAA/MRSPTU/Notifications/117 dated 21.09.2021 keeping in view the Punjab Govt. Notifications No. Tech-TE-2013/4/2021-4TE2/1/229119/2021, No. Tech-TE-2013/4/2021-4TE2/1/229120/2021, No. Tech-TE-2013/4/2021-4TE2/1/229127/2021, No. Tech-TE-2013/4/2021-4TE2/1/229126/2021, No. Tech-TE-2013/4/2021-4TE2/1/229122/2021, No. Tech-TE-2013/4/2021-4TE2/1/229123/2021 & No. Tech-TE-2013/4/2021-4TE2/1/229132/2021 dt 13.08.2021, No. Tech-TE-2013/6/2021-4TE2/1/233021/2021, No. Tech-TE-2013/4/2021-4TE2/1/232895/2021, No. Tech-TE-2013/6/2021-4TE2/1/233016/2021 & No. Tech-TE-2013/6/2021-4TE2/1/233017/2021 dt 19.08.2021 (enclosed **Annexure-1**). Programs offered by University were categorized as-(i) AICTE approved Courses (ii) University Approved AICTE course (UA-AICTE/PCI/CoA) (iii) Non-AICTE/ UGC and (iv) All Skill certificate courses. The last date of admission was 30.11.2021 for all courses offered by University (enclosed at **Annexure-2**).

Further, verification teams were constituted for admission verification of the online admission data sought from IKGPTU and MRSPTU Admission portal vide no. DAA/MRSPTU/2021/3479 dt 07.12.2021, DAA/MRSPTU/2021/3488 dt 15.12.2021, DAA/MRSPTU/2022/3526 dt 06.01.2022, DAA/MRSPTU/2021/ 3512 dt 30.12.2021, DAA/MRSPTU/2022/3549 dt 18.01.2022, DAA/MRSPTU/2021/3491 dated 16.12.2021, Ref. No. 3074 dated 13.12.2021 under the overall supervision and coordination of Assistant Dean (Academics) (enclosed at **Annexure-3**). Colleges were asked to appear for original documents verification before the respective committees in the above rounds.

Regarding admission to Supernumerary Tuition Fee Waiver Seats after centralized online counselling conducted by IKGPTU, Kapurthala in First Year & Lateral Entry in various streams at University Main Campus/ Constituent/ PITs/ Affiliated colleges of MRSPTU, Bathinda for session 2020-21 was conducted as per schedule and procedure notified by Chairman Admission (2021-22) (attached at **Annexure-4**).

Further a noting regarding the admissions which were not confirmed/locked on admission portal by various affiliated colleges of MRSPTU for session 2021-22 Admissions has been approved with a fine of Rs. 500/- by competent authority vide no. VC/591 dated 28.12.2021. Thereafter a noting regarding the students who were not registered on admission portal for session 2021-22 has been approved with a fine of Rs. 10,000/- per student vide no. VC/662 dated 01.02.2022 (enclosed at **Annexure-5**).

Furthermore requests were received from some colleges whose student verifications were pending due to one or another reason, the case of those students were put up before the Hon'ble VC and approval was accorded with fine Rs. 1000/- & Rs. 2000/- respectively vide no. VC/663 dt 01.02.2022 and VC/687 dt. 17.02.2022 (enclosed at **Annexure-6**).

After all the above rounds of admission verification some students had pending Migration/Gap Certificate who were issued university roll numbers subject to condition that they shall submit the Migration/Gap certificates before 31.03.2022, thereafter a fine of Rs. 1000/- will be imposed per document per month to each student with approval from the competent authority vide no. VC/659 dated 31.01.2022 (enclosed at **Annexure-7**).






