- 6. Terms and Conditions may change upon approval by Competent Authority and shall be applicable accordingly from time to time.

- 5. Each Tech-transfer should involve honorarium/award of 1.0 Lacs or above. This monetary grant/award should be separate from research grant.
- 6. If the product/technology is an outcome of research grant, related proof should be accompanied.
- 7. Terms and Conditions may change upon approval by Competent Authority and shall be applicable accordingly from time to time.
- 8. University reserves the right to confer the awards anytime in the subsequent year(s).

* Conditions

- 1. All faculty members of University campus departments and various constituent colleges are eligible to apply for the same.
- 2. The applications for the same will be invited by IQAC every year. The application(s), on prescribed performa, with all relevant proofs must be received timely in IQAC office.
- 3. All applications will be evaluated and recipients shall be selected by a committee, constituted by Vice Chancellor.
- 4. All publications should mandatorily bear affiliation of MRSPTU.
- 5. Proof of SCI Impact Factor and Copy of complete paper must be provided along with the application.
- 6. Impact factors other that SCI will not be considered.
- 7. In case of book, appropriate proof of publication highlighting contribution of faculty and details of publisher must be submitted.
- 8. In case of award/recognitions, relevant proofs must be attached. Evaluation Committee will decide about the status of awarding agency.
- The paper/Book should be published in the academic year (June of preceding up to July
 of subsequent year). No pre-proof or ahead of print publications will be counted for this
 purpose.
- 10. Terms and Conditions may change upon approval by Competent Authority and shall be applicable accordingly from time to time.
- 11. University reserves the right to confer the awards anytime in the subsequent year(s).

Category 5: Overall Achievement Awards

2	MRSPTU Excellence Award	Faculty member, recipient of 5 or more awards from all categories in Research and Innovation Awards, for three consecutive academic years. OR Faculty member, recipient of 15 or more such awards from all categories in Research and Innovation Awards, in three consecutive academic years.

* Conditions

- 1. All faculty members of University campus departments and various constituent colleges are eligible to apply for the same.
- 2. The application must be received in IQAC office for the same by the applicant on prescribed performa with all relevant proofs after declaration of yearly awards.
- 3. All applications will be evaluated and recipients shall be selected by a committee, constituted by Vice Chancellor.
- 4. Terms and Conditions may change upon approval by Competent Authority and shall be applicable accordingly from time to time.
- 5. University reserves the right to confer the awards anytime in the subsequent year(s). However, conferring these prestigious awards in forthcoming Convocation of the University will be preferred.
