
#### **MAIN FUNCTIONS:**

**QUORUM:**

Quorum of the BoS meeting shall be minimum of half of the members of the BoS constituted including the Chairperson of the BoS.

In case of Change of Head of Deptt during the tenure period of BoS, the new appointed Head of Deptt shall take over as Chairperson of BoS ex-officio. The term of members expires after 2 years from the notification or till they hold official positions as above, whichever is earlier.
