- f) Above BoS shall work under the jurisdiction of 'Faculty of Sciences' and hence recommendations of BoS shall go to Faculty of Sciences. Thereafter, recommendation of Faculty of Sciences shall go to o/o Dean Academic Affairs MRSPTU Bathinda.

**QUORUM:**

Quorum of the BoS meeting shall be minimum of half of the members of the BoS constituted including the Chairperson of the BoS.

In case of Change of Head of Deptt during the tenure period of BoS, the new appointed Head of Deptt shall take over as Chairperson of BoS ex-officio.

The term of members shall expire after two years or till they hold official positions as above, or until further orders, whichever is earlier.
