In the event of a student withdrawing before the start of the Course, the entire Fee collected from the student, after a deduction of the processing Fee of not more than Rs.1000/- (Rupees One Thousand only) shall be refunded. School/ Institution Leaving Certificates in original will be returned back to students.2. In case, if a student leaves after joining the Course and if the vacated seat is consequently filled by another student by the last date of admission, the fee collected shall be refunded after a deduction of the processing Fee of not more than Rs.1000/- (Rupees One Thousand only) and proportionate deductions of monthly Fee and hostel rent, where applicable.3. In case the vacated seat is not filled, only the Security Deposit will be refunded and documents in original will be returned back.4. No fee will be demanded for the subsequent years from the students cancelling their admission at any point of time. Fee refund along with the return of Certificates should be completed within 7 days. <p>The counselling fee of ₹3000 per student is non-refundable and is separate from the processing fee.</p>
