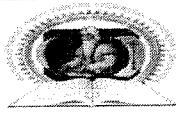

TERMS AND CONDITIONS OF ~~USED~~ MATERIAL

1. The bidders are requested to quote their rates in per kilogram for the Used Answer sheets material. The reserve price for the same is Rs. 23/- per Kg.
2. The approximate quantity of the material is tentative and may vary during actual lifting/weighing. The amount payable to MRSPTU will be based upon the actual quantity lifted and the highest quoted rates will be accepted.
3. The material in whole quantity will be handed over to the successful bidder only after receiving the full payment.
4. The amount of Rs. 35,000/- as Performance Security will be taken from all the bidders in shape of DD from a commercial bank in the name of Registrar, MRSPTU, Bathinda before the public auction. The same will be returned to all the bidders except H1.
5. The successful bidder has also to pay an additional amount of rupees 85,000/- as earnest money on the spot in shape of DD from a commercial bank in the name of Registrar, MRSPTU, Bathinda. The amount of performance security and earnest money will be adjusted/returned after the completion of all formalities and obligations.
6. MRSPTU reserve all the rights to cancel the bid if not satisfied with the rates.
7. The packing of the material and charges of transport, freight, loading and unloading etc. will be arranged by the bidder at his own expenses only on working day. University will not supply any bags/boras/cartons/other items for packing the material.
8. The Registrar, MRSPTU will allow extension upto two weeks on the request of firm by recording in writing that exceptional circumstances were beyond the control of the firm and there was no loss to the university.
9. The successful bidder will carry the material within 20 days from the date of work order. If the material is not lifted within the extended period or stipulated period given in the work order, a penalty of Rs. 200/- per day will be imposed maximum for delay of 30 days which will be recovered from the performance security and in case of delay by more than 30 days the entire amount of performance security will stand automatically forfeited and work order deemed to be cancelled.
10. If the H1 firm backs out then the price quoted by H1 bidder will be offered to H2 for carrying out the items at H1 quoted rates. If H2 bidder is not willing, offer will be given to H3 and so on.
11. G.S.T will be applicable @ 5% of the total value of the material.
12. T.C.S will be collected at 1% from the successful bidder firm being extra the total amount (included GST).
13. Bidders can see the material in person on any working day from Monday to Friday between 10.00 A.M. to 4.00 P.M. at MRSPTU, Bathinda.




Rights of the University:
