In case of the non-availability of Dean (Faculty of Engineering & Technology), the Chairman Board of Studies (Mechanical) shall act as Chairperson, In case Chairperson BoS is non-Ph.D, senior most professor of the department should act as Chairperson DDRC in absentia of Concerned Dean, provided he/she fulfils the condition mentioned in MRSPTU Ph.D Regulations-2016 in regard to Chairman DDRC. Also in such cases, next senior professor shall act as convener of DDRC. It is also to ensure that supervisor cannot be the Chairperson of the DDRC of her/his own candidate/s. Presence of atleast four members of DDRC (including outside expert) shall form the quorum.
