NOTIFICATION

Provisional Admission Process for the Session: 2026-27

Consequent upon the approval of competent authority vide DIARY No./VC/25 dated 15.01.2026, it is hereby notified that the **Provisional Admission Process** of **Maharaja Ranjit Singh Punjab Technical University, Bathinda** (for its **Main Campus and Constituent Colleges**) subject to the fulfillment of eligibility and other requirements for the **Academic Session: 2026-27** shall be started *w.e.f. 15th January, 2026* (via Online Provisional Admission Portal) **upto the start of Centralized Counseling** for the interested candidates as per the following conditions:

1. Candidates are allowed for the Provisional Admission (Session: 2026-27) on the basis of First Come First Serve in the Programs/Courses as per the recommendations of Associate Dean (Academic Affairs)/Directors of Constituent Colleges/Respective HoDs of the concerned departments.
2. The Registration/Counseling Fee is Rs. 3,000/- (Non-Refundable). The candidate are allowed the provisional admission by depositing an additional partial amount of Rs. 10,000/- after submitting Undertaking (in online mode) by the candidate. However, the Candidates eligible for PMSS (Post-Matric Scholarship Scheme) need not to deposit above-mentioned additional partial amount to allow provisional admission. The above paid partial fee shall be adjusted in Total Semester Fee to be paid by the candidate.
3. In case candidate wants to surrender his/her seat taken through provisional admission and/or fails to fulfillment eligibility criteria etc., the amount of Rs. 10,000/- and Applicable Registration/Counseling Fee will not be refunded.
4. The University has all rights to cancel the provisional admission of any candidate due to administrative reasons. In that case, the University will refund Rs 10,000/- deposited as partial fee for provisional admission.
5. These admissions are purely provisional and the final confirmation subject to the fulfillment of eligibility requirements, merit of admission and all other requirements for the Admission Process.
6. Candidates can refer the program/ course fees as notified for the Academic Session: 2025-26 till fee notification for 2026-27 comes into force.
