
1. You are requested to quote the rates for installation of Internet Leased Line connection of 64 MBPS, 1:1 dedicated unshared bandwidth over fiber including necessary hardware at Punjab Institute of Technology, GTB Garh, Moga.
2. Following shall be taken note of while quoting the rates: -
 - a. The rates will be F.O.R., Punjab Institute of Technology, GTB Garh, Moga.
 - b. Rate of GST if extra must be mentioned clearly.
 - c. Quotation received later than due date is liable to be ignored/rejected.
 - d. Quotation must be submitted on letter head of the firm in sealed envelope with all particular, any other format will not be acceptable.
 - e. The quality of the items to be quoted should be best available in the market.
 - f. The bill of he bandwidth will be paid on monthly basis.
 - g. The envelope must bear the word: -

"QUOTATION FOR" providing installation of Internet Leased Line connection of 64 MBPS, 1:1 dedicated unshared bandwidth over fiber at Punjab Institute of Technology, GTB Garh, Moga.

Important: - In the absence of information as required under 2(g), if an envelope is received & opened inadvertently, the Institute will not be responsible and the quotation may not be considered even if quoting lowest rates.

The quotation duly completed should be in the Name of **Director PIT, GTB, Moga** and should reach the **Office the Director Punjab Institute of Technology, GTB Garh, Moga** within 21 days i.e. latest by 20.02.2025 up to 11:00 AM by speed post/registered post/by hand in closed & sealed envelope. The same shall be opened at 11:30 AM on that date. Your company representative may be present during the opening of the quotations.

Sr. No.	Specifications for Internet Connectivity from Two different Vendors for lease line 64 MBPS for PIT GTB Garh, Moga with 1:1 dedicated unshared bandwidth over Fiber (Including Installation & with all required accessories for lease line) for one year.
1.	ISP Type Class A
2.	Hardware (Fiber link/Radio link/Leased Line Modems, Routers, Antenna(s) and/or other necessary hardware, if required, to be provided by Vendor.
3.	Software required establishing the required link to be provided by Vendor.
4.	ISP has to provide min 06 Global IP Numbers to be provided by Vendor.
5.	Bandwidth monitoring system, Internet router port at ISP Gateway for required bandwidth, to be provided by Vendor.
6.	Liaison with BSNL/Govt. Deptt.(s) for obtaining point connectivity between ISP node and WPC clearance. If required, to be done by Vendor.
7.	Installation, configuring of the link and necessary hardware/software, commissioning to be done by Vendor.
8.	Warranty of equipment supplied along with bandwidth for the period of contract.
9.	Maintenance Support Service (24 Hours 7 Days a Week) for bandwidth and equipment/software.
10.	Reports for performance monitoring/usage to be submitted on monthly basis.
11.	Packet Losses: Less than 1%
12.	Availability of services: 99%
13.	In case of above parameters going out specifications, payment will be deducted for those periods on per minute basis.
14.	Institute required Internet connectivity for Institute & in Hostel on sharing basis, necessary hardware need to be installed by vendor.

Note: -

- i. The Vendor should clearly indicate the different component of total charge Recurring (annual) and Non-Recurring (one time) including bandwidth, equipment supplied.
- ii. payment will be made on quarterly basis; payment of last quarter has to be paid after completion.
- iii. In case of downtime, payment will be deducted for those periods on per minute basis.
- iv. Initially contract period will be for one year and can be extended for one year or part thereof on the same rates which are quoted in the financial bid, if required by the Institute (maximum for 02 years).
- v. The preference of media may be ignored by committee members if there will be more than 10% variation in total quoted rate of 1st lowest & 2nd lowest party.
- vi. Services to be started for 64 MBPS lease line from 1st April 2025 onwards for one year.
