Provisional Admission Process for the Session: 2025-26

Consequent upon the approval of competent authority vide DIARY/No./181 dated 19.02.2025, it is hereby notified that the Provisional Admission Process of Maharaja Ranjit Singh Punjab Technical University, Bathinda (for its Main Campus and Constituent Colleges) subject to the fulfillment of eligibility and other requirements for the Academic Session: 2025-26 shall be started w.e.f. 25th February, 2025 (via Online Provisional Admission Portal) upto the start of Centralized Counseling for the interested candidates as per the following conditions:

- 1. Candidates are allowed for the Provisional Admission (Session: 2025-26) on the basis of First Come First Serve especially in those Programmes where the admission in last two years remained low. HoDs of the concerned departments shall recommend the name(s) of Programmes and the number of seats in the Programmes run by respective departments to be considered for Provisional Admissions to o/o DAA MRSPTU by 21/02/2025. Associate Dean (Academic Affairs)/Chairman (Admissions) will take decision in this regards as per requirement considering the actual admission scenario.
- 2. Candidates will deposit Registration/Counseling Fee of Rs. 3,000/- (Non-Refundable) and additional amount of Rs. 10,000/- (as partial fee for provisional admission) for the Academic Session: 2025-26 and allowed for provisional admission in his/her Programme (Discipline/Branch) of choice, after submitting Undertaking. The above paid fee shall be adjusted in Total Semester Fee to be paid by the candidate.
- 3. In case candidate wants to surrender his/her seat taken through provisional admission and/or fails to fulfillment eligibility criteria etc., the amount of Rs. 10,000/- and Applicable Registration/
 Counseling Fee will not be refunded.
- 4. SC Candidates who wish to avail and eligible for PMSS, are also be allowed to deposit Applicable Registration/Counseling Fee (Non-refundable) for the provisional admission (Academic Session: 2025-26) after submitting Undertaking.
 - 5. The University has all rights to cancel the provisional admission of any candidate due to administrative reasons. In that case, the University will refund the whole fee paid by the candidate.
 - 6. These admissions are purely provisional and the final confirmation subject to the fulfillment of eligibility requirements, merit of admission and all other requirements for the Admission Process.
 - 7. Candidates can refer the notified fees for the Academic Session: 2024-25 till fee notification for 2025-26 comes into force.
 - 8. The candidates will submit an undertaking (online or offline) for taking provisional admission.
