Subject: Addition of BCA and B.Sc. Programmes to the Business Class Course (2026 Batch onwards).

Consequent upon the approval of the Competent Authority vide Dairy No. VC/744 dated 25.09.2026 and in accordance with the latest directives issued by the **Directorate of Higher Education, Punjab**, vide Ref. No. 1349/D.H.E. dated 18 September 2026, regarding the state-level rollout of the **Business Class Programme**, the revised implementation guidelines for Undergraduate (UG) degree programmes are hereby notified as under:

The mandatory **2-credit course** of Business Class shall be implemented with effect from the **2026 Batch onwards** for students enrolled in **B.Tech., BBA, B.Com., B.Voc., B.A., B.Sc. and BCA Programmes**.

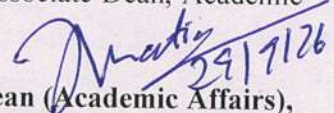
For other Undergraduate programmes not covered above, offering the Business Class course shall be optional. Departments interested in offering the course to students of such programmes may intimate the Office of the Associate Dean, Academic Affairs, indicating the programme/course details, for further necessary action and incorporation in the academic/registration system, wherever applicable.

The course nomenclature, codes, and credit structure across the 1st to 5th semesters are as per the following **until further revision of the scheme**:
