

Uniform discount on publisher's price for the books in the area of Engineering, Architecture, Sciences, Pharmacy, Food Science, Agriculture etc and general books be given latest by date **February 26, 2026 12:30 p.m** and the received offer letters will be opened at **03:30 p.m** on the same day.

and conditions for empanelment of vendors for purchase of books

1. Registrar, MRSPTU Bathinda reserve the exclusive right to reject any or all quotation without assigning any reason whatsoever. Further, Registrar, MRSPTU reserves the right to delete any or all vendors/suppliers from the empanelment list based on unsatisfactory performance.
2. The vendor/supplier will submit a Demand Draft (DD) of Rs. 10,000 in favour of Registrar, MRSPTU Bathinda as a security deposit. The security amount will be refundable after two years, at the time of issuing a fresh invitation for new empanelment. The security deposit will be liable to forfeit in case the vendor/supplier fails to supply books as per agreed terms and conditions.
3. The empanelment shall be valid for a period of 02 years from the date of finalization of the Book Vendors Empanelment process and may be extended by an additional one year.
4. The vendor should submit a valid registration certificate of their Book Shop/Office/Firm.
5. The vendor should have an experience of satisfactory supplying the books in minimum 05 (five) libraries of Universities/Institutions.
6. The participating vendors must give consent of supply of at least 75% of books from the order they awarded, failing which any action may be taken by the library against them, like, cancellation of order, declaration of Black listing of vendors, no future participation for future empanelment of those type of firms and their security will be forfeited, etc.
7. The supply order shall be valid for 30 days only from the date of dispatch after that, the order automatically stands cancel. This may be extended by the Registrar up to fifteen days on genuine cases; otherwise, the order shall stand cancelled.
8. In case of foreign edition, a certificate would be required from the supplier that 'Indian reprint/edition is not published" for the title (mention the name of title). The publisher's original print version of book should be supplied.
9. Only Paper Back edition would be supplied, wherever available. If Paper Back editions are not supplied then a certificate would be submitted stating that 'No Paper Back edition for the Book(s) mention the name of title(s) is/are available'. The book (s) must be of latest edition of publisher's print copy not Xerox/photo copy.
10. Foreign exchange rates shall be charged according to Good Office Committee (GOC) report rates or bank rates.
11. The cost of transport shall be borne by the supplier.
